### **PERFORMANCE FOOD GROUP ANNOUNCES OPENING OF REPLACEMENT FACILITY IN GEORGIA**

**RICHMOND, Va. (Feb. 15, 2008)** — Performance Food Group Company (NASDAQ/NGS: PFGC) announced today it has opened its 113,000 square foot distribution facility in Cairo, Ga. The new facility replaces the Company's current location in Thomasville, Georgia, opened in 1931, and provides PFG with capacity for growth. The completion of this state-of-the art facility doubles the capacity at this location, and allows for 2,500 additional products.

PFG-Powell, a subsidiary of Performance Food Group, serves customers in South Georgia, South Alabama and North Florida, including schools, healthcare facilities and independent restaurants. In addition to its current associate base, the new PFG-Powell facility anticipates adding approximately 50 new jobs over the next five years.

"This was an exciting opportunity to be able to expand our business in this tri-state community," said Buddy Parrish, president, PFG-Powell. "Our expansion enables us to better serve our existing customers and grow with potential new business, as well as offering us the opportunity to create new jobs."

Steven Spinner, president and CEO, added, "Our Cairo project is part of our continued investment in growing Performance Food Group. In addition to this project, we recently completed a facility enhancement in St. Louis, Missouri and opened a replacement facility in Springfield, Massachusetts."
